This Annex B forms an integral part of the Membership Application Form and upon acknowledged and signed by the Applicant, it shall be binding.

Terms & Conditions for Membership Application

1. Membership

- Membership is subject to approval and is non-transferable.
- Entrance fee paid and subscription fees are non-refundable.
- Application must be accompanied by relevant supporting documents.
- A member found to have provided misleading information will have his/her membership revoked.
- SAFYC may obtain updates of your personal data from MINDEF/SAF or other channel subsequently to serve you in a most efficient and effective way.
- All monthly subscription fees are payable in advance.
- A married applicant falls under the **Ordinary (Family)** membership status. This covers the principal member, spouse and children below 21 years.
- Dependent membership for the child shall lapse when the child reaches 21 years of age.
- Member shall abide by the Club Constitution and Bye-laws
- SAFYC is to be notified immediately of any changes in employment status, mailing address, contact number, email address and/or other personal particulars that may affect the membership status. The Club will not be responsible for any loss or damage that may arise due to incorrect or outdated records.
- Ordinary Young Adult Term, Associate Young Adult Term and Special Term Members can **only bring along ONE (1) Guest** to the Club at any time.
- Ordinary Young Adult Term, Associate Young Adult Term, NSF Term Members and Special Term Members are **not entitled** to berthing / mooring facilities.
- Ordinary Young Adult Term and Associate Young Adult Term membership is renewable on an annual basis up to 28 years of age.
- Ordinary Young Adult Term and Associate Young Adult Term members aged 29 to 35 are only eligible for 1-year term membership.
- Special Term Membership is renewable one time only after first time application. Subsequently, member can convert to other relevant membership type.
- NSF Term Membership shall expire upon ORD.
- SAFYC reserves the right to amend the Terms and Conditions without prior notice.
- A Refundable Deposit Fee equivalent to **3 months** of the signing-up membership subscription fees applies upon new membership sign-up. Deposit Fee cannot be used to off-set any current outstanding amount due upon termination of membership. Refund will be applicable after all outstanding amount are being settled.

2. Payment

- All dues must be settled promptly prior to from the due dates of the statement of account.
- An administrative charge of \$50 shall impose on late payments exceeding 4 weeks.
- Further administrative charge of \$80 shall impose on late payments exceeding 6 weeks.
- Membership shall suspend upon defaulting payment for more than 12 weeks.
- A charge shall be imposed for membership reinstatement within three years from date of resignation.

3. Lost and replacement of Membership Cards

- Member is to notify the club immediately upon loss/ misplacement of membership card. A replacement fee of \$10 shall apply.

4. Resignation of Membership

- A month's notice is to be given to the Club in writing for resignation.
- Monthly subscription fee will continue to be payable regardless of whether the member uses the Club's facilities/benefits until notice of resignation is given in writing.
- All outstanding sums on installment or otherwise are to be settled in **FULL** before resignation is deemed to be effective.
- Interest shall continue to accrue on all outstanding until all dues are settled.
- Upon resignation, all membership cards are to be returned to SAFYC.
- Membership validity and related privileges shall lapse when the Principal member resigns, ceases to be a SAFYC member, or when his membership is suspended.

5. Application for Absentee Status

- Absentee application is open to all members who travel overseas for a period between six months to two years.
- Application must be accompanied by the relevant supporting documents and is subjected to the approval by Management Committee.
