Conditions for Powered Pleasure Craft Charter

1. Powered Pleasure Craft Charter is only available to SAF Yacht Club members only.
2. Member chartering the Powered Pleasure Craft MUST be in possession of a valid PPCDL.
3. Day-charter @ block of 4 hours

4. Extension hours of charter up to 2 hours shall be at \$50 per hour. Any extension beyond 2 hours will be charge at block chartering rate. Day charter can be extended to 1800 hrs only on weekdays and 1900 hrs on weekends / public holidays.

5. Morning commence at 0900hrs & Latest commence at 1500hrs

6. The crafts carrying capacity must not be exceeded.
7. Additional fuel consumed after the first tank is chargeable. There shall be NO refund for the unconsumed first tank of fuel.
8. Member chartering the craft is responsible for the craft and its equipment/accessories until they are handed back to SAF Yacht Club
9. Member chartering the craft will be liable to reimburse SAF Yacht Club the cost of petrol consumed, repairs and/or replacement for any damage or loss incurred to the craft during the period of charter, howsoever caused
10. SAF Yacht Club, its officers and employees are not liable for any accident, loss, damage and/or injury suffered by the member, their family or guests during the period of the charter whether such accident, loss, damage and/or injury occurred ashore or afloat.

11. Power Pleasure Craft charter cancellation Fee:

Less than 48hrs – 50% of charter fee

Less than 24hrs – Full amount due

12. The charter period shall be as per the booking period. Member shall take over craft 15 minutes before actual charter commence time to avoid any delay.
13. The member shall abide by MPA Port and Pleasure Crafts Regulations during the charter and shall absolve SAFYC from all liabilities resulting from any breach of these regulations.
14. Where a craft is assigned / chartered is unavailable due to mechanical fault, SAFYC reserves the right to replace with another craft of similar carrying capacity.
