RESERVATION GUIDELINES AND REGULATIONS

Eligibility

1. SAF Yacht Club Members are eligible to reserve 3 months in advance for the SAF Yacht Club Resort Rooms.
2. Guests are eligible to reserve 1 month in advance for Normal & Peak Period and 2 weeks in advance on PH & eve of PH for the SAF Yacht Club Resort Rooms.

Reservation

3. Guests are required to make full payment upon registration for confirmation of room booking.

Cancellation

4. For request of cancellation or change of reservation, the following guidelines / charges will apply.

Type of Request	Confirmation Of Booking	Cancellation Charges
Cancellation of Reservation	More than 30 days from check-in date	20% Of Rooms Rate
	2 Weeks from Check-In Date	30% Of Rooms Rate
	1 Week from Check-In Date	40% Of Rooms Rate
	48 Hours from Check-In Date	50% Of Rooms Rate
	24 Hours from Check-In Date	75% Of Rooms Rate
Change of Reservation Date is subjected to availability	More than 14 days from Check-In Date	\$20 Admin Fee Per Request And Subject To Room Availability

Checking of Resort Room Inventory

5. Occupants shall check the inventory in the Resort Rooms upon check-in and contact the Front Desk at **ext. (0)** for any discrepancy immediately.
6. Occupants will be liable to pay for any losses or damage in the Resort Rooms and its grounds.

Restrictions

7. No subletting of room is allowed.
8. No pets are permitted in the Resort Rooms.
9. Twin & Honeymoon Suite rooms - up to 3 occupants allowed.
10. Family room - up to 6 occupants allowed.
11. Gambling, possession and viewing of uncensored/illegal DVD/discs are not allowed.
12. Organising activities that are not conforming to any written laws are prohibited.
13. Occupants are to ensure that noise is kept to a minimum.
14. No private parties or functions are to be held inside the rooms.
15. No smoking is allowed inside the rooms.
16. Occupant is to conform to the number of guest/s staying in the room.

Indemnity

17. The Management and Staff shall not be responsible for the loss of any valuables, money or personal belongings during the stay.
18. The Management and Staff will not be held liable for any injury or accident sustained by occupants/guests during their stay in the SAF Yacht Club Resort Rooms.

Rights of SAF Yacht Club Resort Rooms Management

19. SAF Yacht Club reserves the right to take any action it considers necessary against any occupant found misusing the SAF Yacht Club Resort Rooms or disregarding the regulations. Such action may lead to the occupants being evicted immediately from the premises without refund of the rent already paid.
20. Occupants of the SAF Yacht Club Resort Rooms have to permit reasonable access and inspection of the premises by the staff of SAF Yacht Club / Security.
21. Any violation of the regulations or any false declaration will render the occupants liable to be evicted from the SAF Yacht Club Resort Rooms and be barred from future applications, including disciplinary action.
