General Terms and Conditions :

1. Applicant must fulfil the Absent Member requirement and condition as stated in the Club Constitution (Clause 5.19) and Club Bye-Laws (Clause 2.1).
2. Absent Application is open to only lifetime members.
3. Application must be accompanied by travel document and company letter for approval. Failure to supply such document proof will lead to rejection of application.
4. Application cannot be back-dated.
5. All member's (and member's family, if applicable) privileges and rights will be withdrawn during the absent period. Public rates will apply should Absent Member wish to utilize club services and facilities during his/her absent period. Otherwise, he/she will need to activate their membership for at least 3 months to reinstate his/her membership privileges and rights.
6. Absent Member is responsible to inform the club of his/her return to the country immediately and notify to terminate his/her absent status.
7. Absent Member is subjected to random verification on his/her oversea status by the Club, via means including but not limited to contacting the employer/family members.
8. Absent status will be revoked immediately without notice should Absent Member being discovered to have returned to country prior the end of absent period. Subscription fee will be back-dated to the date of return for the member.
9. Request to extension of absent period must be submitted 3 months prior the expiry of existing absent status. Otherwise, membership will be reverted automatically to "Active" status where monthly subscription fee will incur.
10. In case of dispute, the Club Management and the Management Committee will have the final decision.

Fees :

1. Fresh application : 3 months of membership subscription fee per application
2. Extension application : 1 months of membership subscription fee per application
